

### HOLD HARMLESS AGREEMENT, WAIVER AND RELEASE

The undersigned, an artist participating in an ArtWalk San Diego show JUDY MANDEL [name of artist], has registered to participate in one of ArtWalk's three annual events (Mission Fed ArtWalk, ArtWalk @ Liberty Station and/or ArtWalk Carlsbad offered by Art For People, Inc, DBA of ArtWalk San Diego a corporation existing under the laws of the State of California. The undersigned acknowledges that there are dangers and risks of personal injury, harm, damage or property loss for participation in public shows. Knowing and acknowledging this, the undersigned hereby, freely assumes any and all risks of bodily injury, harm, damage, or property loss associated with participating in art festivals.

The undersigned, in consideration of the opportunity to participate in these events, and for other good and valuable consideration, does hereby FOREVER RELEASE AND DISCHARGE ArtWalk San Diego, Art for People Inc, the City of San Diego, and the Little Italy Association of San Diego, Arts District Liberty Station, and the City of Carlsbad, their members, directors, employees and agents, and any and all owners of property on which the art festivals are held, and does hereby indemnify and hold each of them harmless, from and against any and all claims, actions, causes of action, liability, damages, expenses and/or personal injuries and/or property damage and/or death arising out of or resulting from any classes and other events and programs offered by Art for People, Inc.

The undersigned further declares and represents that no promises, inducements or agreements not herein express have been made, that this Hold Harmless Agreement, Waiver and Release contains the entire agreement between the parties, and that this Hold Harmless Agreement, Waiver and Release shall be binding on the undersigned and his or her estate, heirs, executors, personal representatives, successors and assigns.

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ANY/ALL ACTIVITIES ASSOCIATED WITH ArtWalk San Diego festivals, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.

The Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

The undersigned does hereby represent that he/she is, in fact, acting in such capacity and agrees to save and hold harmless and indemnify each and all of the parties referred to above from all liability, loss, cost, claim or damage whatsoever which may be imposed upon said parties because of any defect in or lack of such capacity to so act and release said parties on behalf of the minor and the parents or legal guardian.
